George made a motion to allow Marilyn to sign up with Dropbox at a cost of \$15/month. Jeff seconded and the motion was passed.

COMMISSIONERS' CONCERNS:

George – He presented some ideas for other park activities this fall like a food truck event, a potluck, or an arts and crafts sale. He asked other commissioners to let him know if they have any ideas. George will check with John Barrow to see if Strathmoor Village has something similar already planned.

Jeff – All the road/curbing construction has been completed and the online application was filed for a \$1500 liability grant from the Kentucky League of Cities for the sidewalk work completed by PPC during July 2022.

Aliki – The Halloween Parade is October 29th at 6PM. She will ask neighbors via Next Door to come to the park and bring chairs and prepare to give out candy to the participants. This is a slight change from past years where only one person handed out the candy at the end of the parade.

Tom – All signs have been finished and will be installed in the next couple of weeks.
