The meeting was called to order at 7:00PM by Mayor Schlindwein.

ANNOUNCEMENT:

Marilyn will put out an email asking if anyone is interested in the commissioner's role, both for the rest of Alik's term and for the next term. Andy mentioned a resident he knows that has expressed an interest so he'll get with her physically.

PREVIOUS MONTH'S MINUTES:

Alik made a motion to accept the September Commissioners' meeting minutes with changes discussed. Ron seconded and the motion was passed.

POLICE REPORT:

Prior to the meeting, Chief Lamey submitted to Tom his report for September as follows:

SNOW REMOVAL CONTRACT:

STREET SIGNS:

Andy submitted a quote from Best Sign Co to replace and install the speed limit sign on Kings Hwy that was damaged when a tree fell on it at a cost of \$175. (\$75 for the sign, \$50 for the post, \$50 for installation.) Ron made a motion to authorize Andy to purchase a new street sign and pole with Best at a cost of \$175. Aliki seconded and the motion was passed.

OLD BUSINESS:

George – He communicated prior to the meeting that he has not heard from Brandon Moore, the Strathmoor commissioner in charge of the picnic, anything about their payments for their portion of the picnic.

COMMISSIONER'S COMMENTS:

Aliki – Asked all commissioners to come to the Trunk or Treat and set up a table on October 28<sup>th</sup> at 2:00. She had asked Strathmoor Village if they wanted to be part of the event, but their commissioner declined.

Ron— No issues
