#### 2nd reading of 2025-26 Ad Valorem Tax Ordinance

Finn read the second reading of the Ad Valorem Tax, Ordinance No. 1, Series 2025. Dary made a Motion to approve the Ordinance and Jamie seconded it. It was unanimously approved by a roll call vote.

#### 2nd reading of 2025-26 Budget Ordinance

Finn read the second reading of the Budget Ordinance No. 2, Series 2025. Les made a Motion to approve and Jamie seconded it. It was unanimously approved by a roll call vote.

#### Backflow Prevention Device

Lesla received a letter from the Louisville Water Company in April stating that an annual inspection of the Backflow Prevention Valve was mandatory. However, we were unaware that payment had to be made on the day of the inspection. Thus, Tom personally paid it, and Lesla will reimburse him for it.

#### Review of Ordinance No. 3, Series 2025, Amending Ordinance No. 10, Series 2024 Regulating The Removal and Pruning of Trees and Other Plants

#### Bond Refund to Chad Elder for removal and planting new tree

#### Kingsley Park Improvements

Jamie received bid to remove bushes by the Flagpole to improve site line. And in the fall to plant new bushes and flowers. Need motion to approve \$685.00 for Swift Lawn Care for

improvements. Les made motion to approve, Dary seconded and it was unanimously approved.

#### Old Business

No comments from any Commissioners.


#### Mayor's Comments
