Resident Recognition- A house in the 2600 block of Kings Highway has a free library in their front yard. It would be nice to find out the story of why it was put there.

Andy mentioned doing a follow up story on the winner of the Equestrian Enterprises "Horse Camp" winner next summer.

Sidewalks - How often does PCC audit? Every 5 years.

Curbs – EcoTech representative coming out to discuss what can be done about the curb at Montrose and Sydney. Should the island in that area be taken out to make more room for the larger trucks?

#### **Commissioner's Comments**

Andy – Could we send a letter to Speedway asking them to clean up their property? Tom will contact the Assistant Manager.

Les – Has an estimate for the ADA strips from S&S Concrete. \$4,850 for 7 ADA strips. This is to take up the ones that are in anchors and replace them with anchors. It was decided that this estimate is too high.

Also, road funds from the state will be down significantly for the next two years.

# **Mayor's Comments**

Complaint from resident regarding house on Kings Highway that the yard was overgrown and the garage was beat up. House is owned by the Hawkins. Tom talked to owner and they cleaned it up. LG &E fixed the blinking streetlight in the easement between 2600 and 2606 Kings Highway. Another rental property of the Hawkins has a dead tree on their property. An arborist has declared that it is dead. If tree should fall or cause damage it will be the Hawkins responsibility since they haven't taken it down.

One house is now up for sale and two more will be for sale in the next couple of months – all on Kings Highway.
